List of Prohibited Carry-On and Checked Items for Civil Aviation Passengers

一、枪支等武器(包括主要零部件)

1. Firearms and other weapons (including major components)

能够发射弹药(包括弹丸及其他物品)并造成人身严重伤害的装置或者可能被误认为是此类装置的物品,主要包括:

Devices that may fire ammunition (including bullets and the like) and cause serious bodily harm or that may be mistaken as such devices, mainly including:

- (一) 军用枪、公务用枪, 如手枪、步枪、冲锋枪、机枪、防暴枪;
- (1) firearms designed for military and public security, such as pistols, rifles, sub-machine guns, machine guns, and riot guns;
- (二)民用枪,如气枪、猎枪、射击运动枪、麻醉注射枪;
- (2) firearms designed for civilian purposes, such as air guns, shotguns, sporting firearms, and anesthesia injection firearms;
- (三) 其他枪支, 如道具枪、发令枪、钢珠枪、境外枪支以及各类非法制造的枪支;
- (3) Other firearms, such as prop firearms, starting pistols, BB guns, foreign firearms, and all kinds of illegally manufactured firearms;
- (四)上述物品的仿真品。
- (4) Imitations of the above items.

二、爆炸或者燃烧物质和装置

2. Explosive or flammable substances and devices

能够造成人身严重伤害或者危及航空器安全的爆炸或燃烧装置(物质)或者可能被误认为是此类装置(物质)的物品,主要包括:

Explosive or incendiary devices (substances) capable of causing serious personal injury or endangering aircraft safety, or items that may be mistaken for such devices (substances), mainly including:

- (一)弹药,如炸弹、手榴弹、照明弹、燃烧弹、烟幕弹、信号弹、催泪弹、毒气弹、子弹 (铅弹、空包弹、教练弹):
- (1) Ammunition, such as bombs, grenades, flares, incendiary bombs, smoke bombs, signal flares, tear gas bombs, gas bombs, and bullets (lead bullets, blank shells, coach bullets);
- (二)爆破器材,如炸药、雷管、引信、起爆管、导火索、导爆索、爆破剂;
- (2) blasting devices, such as explosives, detonators, fuzes, detonators, fuses, detonating cords, and blasting agents;
- (三)烟火制品,如烟花爆竹、烟饼、黄烟、礼花弹;
- (3) Pyrotechnic products, such as fireworks and firecrackers, smoke cakes, yellow smoke, and fireworks shells;
 - (四)上述物品的仿真品。
- (4) Imitations of the above items.

三、管制器具

3. Controlled implements

能钞造成人身伤害或者对航空安全和运输秩序构成较大危害的管制器具,主要包括:

Capable of causing body harm or posing a significant risk to aviation safety and orderly transportation, mainly including:

- (一)管制刀具,如匕首(带有刀柄、刀格和血槽,刀尖角度小于60度的单刃、双刃或多刃尖刀)、三棱刮刀(具有三个刀刃的机械加工用刀具)、带有自锁装置的弹簧刀或跳刀(刀身展开或弹出后,可被刀柄内的弹簧或卡锁固定自锁的折叠刀具)、其他相类似的单刃、双刃三棱尖刀(刀尖角度小于60度刀身长度超过150毫米的各类单刃、双刃、多刃刀具)以及其他刀尖角度大于60度刀身长度超过220毫米的各类单刃、双刃、多刃刀具;
- (1) Controlled cutting implements, such as daggers (single-edged, double-edged or multi-edged sharp knives with handles, grids and blood grooves, with a tip angle of less than 60 degrees), three-edged scrapers (with three blades for mechanical processing knives), spring knives or jumping knives with self-locking devices (folding knives that can be fixed and self-locking by springs or latches in the handle after the blade body is unfolded or ejected), other similar single-edged, double-edged and three-edged pointed knives (all kinds of single-edged, double-edged, and multi-edged knives with a tip angle of less than 60 degrees and a blade length of more than 150 mm) and other types of single-edged, Double-edged and multi-edged knives;
- (二)军警械具,如警棍、警用电击器、军用或警用的匕首、手铐、拇指铐、脚镣、催泪喷射器;
- (2) Weapons and tools for military and police use, such as batons, police electric shock devices, military or police daggers, handcuffs, thumbcuffs, ankle shackles, and tear gas sprayers;
- (三) 其他属于国家规定的管制器具,如弩。
- (3) Other controlled implements that are subject to national regulations, such as crossbows.

四、危险物品

4. Dangerous items

能够造成人身伤害或者对航空安全和运输秩序构成较大危害的危险物品,主要包括: Capable of causing serious body harm, endangering aircraft safety and constituting a serious threat to transportation order, mainly including:

- (一)压缩气体和液化气体,如氢气、甲烷、乙烷、丁烷、天然气、乙烯、丙烯、乙炔(溶于介质的)、一氧化碳、浓化石油气、氟利昂、氧气、二氧化碳、水煤气、打火机燃料及打火机用液化气体;
- (1) Compressed and liquefied gases such as hydrogen, methane, ethane, butane, natural gas, ethylene, propylene, acetylene (dissolved in media), carbon monoxide, liquefied petroleum gas (LPG), Freon, oxygen, carbon dioxide, water gas, lighter fluid, and liquefied gas for use in lighters;
- (二)自燃物品,如黄磷、白磷、硝化纤维(合胶片)、油纸及其制品;
- (2) Spontaneously combustible, for example, yellow phosphorus, white phosphorus, nitrocellulose (including photographic film), oil paper, and oil paper products;
 - (三)遇湿易燃物品,如金属钾、钠、锂、碳化钙(电石)、镁铝粉;
- (3) Substances flammable when wet, for example, metals: potassium, sodium, lithium, calcium carbide (calcium acetylide), and magnalium powder;
- (四)易燃液体,如汽油、煤油、柴油、苯、乙醇(酒精)、丙酮、乙醚、油漆、稀料、松香油及含易燃溶剂制品;
- (4) Flammable liquids such as gasoline, kerosene, diesel, benzene, ethanol (alcohol), acetone, diethyl ether, paint thinner, pine rosin, and products containing flammable solvents;

- (五) 易燃固体, 如红磷、闪光粉、固体酒精、賽璐珞、发泡剂;
- (5) Flammable solids, for example, red phosphorus, flash powder, solid alcohol, celluloids, and foaming agents;
- (六)氧化剂和有机过氧化物,如高锰酸钾、氯酸钾、过氧化钠、过氧化钾、过氧化铅、过 醋酸、双氧水;
- (6) Oxidizing agents and organic peroxides, for example, potassium permanganate, potassium chlorate, sodium peroxide, potassium peroxide, lead peroxide, peracetic acid, and hydrogen peroxide;
- (七)毒害品,如氰化物、砒霜、剧毒农药等剧毒化学品;
- (7) Toxic substances, for example, cyanide, arsenic, highly toxic pesticides, and other highly toxic chemicals;
- (八)腐蚀性物品,如硫酸、盐酸、硝酸、氢氧化钠、氢氧化钾、汞(水銀);
- (8) Corrosive substances, for example, sulfuric acid, hydrochloric acid, nitric acid, sodium hydroxide, potassium hydroxide, and mercury (quicksilver);
- (九)放射性物品。如放射性同位素。
- (9) Radioactive substances. For example, radioisotopes.

五、其他物品

5.Other items

其他能够造成人身伤害或者对航空安全和运输秩序构成较大危害的物品,主要包括: Others that may result in body harm or pose a significant risk to aviation safety and orderly transportation, mainly including:

- (一)传染病病原体,如乙肝病毒、炭疽杆菌、结核杆菌、艾滋病病毒;
- (1) Infectious diseases/pathogens, for example, hepatitis B virus (HBV), Bacillus anthracis (anthrax), mycobacterium tuberculosis (TB), and the Human Immunodeficiency Virus (HIV);
- (二)火种(包括各类点火装置),如打火机、火柴、点烟器、镁棒(打火石);
- (2) Sources of fire (including all types of ignition devices), for example, lighters, matches, cigarette lighters, and firesteels (flintstones);
- (三)额定能量超过 160Wh 的充电宝、锂电池(电动轮椅使用的锂电池另有规定);
- (3) Power banks and lithium batteries with rated energy exceeding 160Wh (separate provisions are in place for lithium batteries used in electric wheelchairs);
- (四)酒精体积百分含量大手 70%的酒精饮料;
- (4) Alcoholic beverages that exceed 70% alcohol by volume (ABV);
- (五)强磁化物、有强烈刺激性气味或者容易引起旅客恐慌情绪的物品以及不能判明性质可能具有危险性的物品。
- (5) Strongly magnetic materials, items that have a strong and irritating odor or are likely to cause passengers to panic, and items that are potentially dangerous as their characteristics cannot be determined.
